BROWN and ANNE THOMPSON, as President and Secretary respectively of CAPE SHORES ASSOCIATION, INC., a Corporation not for profit, do hereby certify that at a regularly scheduled meeting of the Board of Directors held on the 3rd day of December, 1977, the Board of Directors by an affirmative vote of more than a majority of the entire membership of the Board of Directors did approve and recommend to the members of the Association, the following amendment to the By-Laws of the Association and that at a regularly scheduled meeting of the Association held on the 9th day of January, 1978, by an affirmative vote of more than two-thirds of the entire membership, the members, did approve the following amendment to the By-laws of CAPE SHORES ASSOCIATION, INC.:

Paragraph Four, subparagraph (a) be and is hereby amended as follows; immediately following the first sentence shall be inserted: "The number of Directors of the Association shall be seven (7) and may be changed at any apecial or annual meeting of the members by amendment of these By-laws as provided herein."

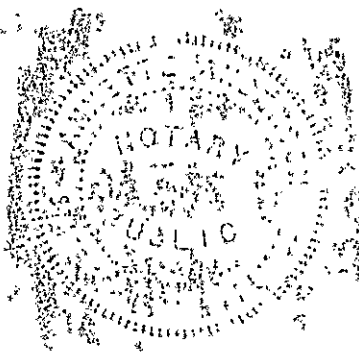
